INFORMATION for APPLICANTS

Applicants are bound by the provisions of the Associations Incorporation Act 2015, plus various other state and Local Government legislation and regulations. Members are also bound to adhere to the Sorrento Bowling Club's Constitution, By-Laws, and Policies of The Club.

If your application for membership is rejected by the Governing Council: You may give notice of your intention to appeal within 14 days of being advised of the rejection (rule 5(4)). The club in a general meeting, no later than the next annual general meeting, must confirm or set aside the decision of the Governing Council rejecting your application, after giving you a reasonable opportunity to be heard or to make written representations to the general meeting (rule 5(5)).

Details of Various Classes of Membership

Full Bowls or Full Croquet Member

Any person over the age of eighteen years shall, upon application to and election by the Governing Council, become a Full Member of the Club.

Rights and entitlements of Full members:

- a) Shall be entitled for election to the Governing Council or various volunteering positions within The Club.
- b) Shall have the right to attend, speak and vote at all General Meetings of The Club.
- c) May play lawn bowls and croquet on all days when The Club is open for play and subject to greens being available. Dress code must be adhered to.
- d) May participate in Club Championship Events, inter club competitions organised by BowlsWA and internal club competitions organised by this club or other clubs, if eligible may attend all social functions organised by The Club.
- e) May bring guests, visitors, and prospective members to The Club to use the facilities provided by the Club.

Recreational Bowls or Croquet Member

Entitles member to play at any time the greens are available, but not participate in Pennants or Club Championships. The Constitution of the club sets out other rights and privileges applicable to recreational members.

Social Member

Social Members shall be elected in the manner prescribed for Full Members and on payment of prescribed fees shall be afforded use of all amenities within the clubrooms.

A Social Member shall not be entitled to hold any office, become a member of any committee, or speak or vote on any matter at any meeting of the Club, neither shall they be entitled to play bowls except at the specific invitation of a member of the Governing Council.

Junior Members

Any person having attained the age of twelve years and being under eighteen years shall, upon application to and election of the Governing Council, become a Junior Member of the Club. Junior Members shall not bring any guest into the Club premises.

A list of current membership fees is posted in the club rooms.

Rights and Privileges

Provisional, Junior, Social, Country and Honorary Members shall not have any right title or interest in or to any property of the Club nor propose or second any candidate for admission as a member nor are they entitled to hold office in the Club to speak or vote at any meeting.
